The PERMITTEE is granted a permit to use Lake Cuyamaca Recreation and Park District facilities for _____ day(s). The term of this permit begins on _____ and ends on _____, 2_____. This permit includes the use of grounds, equipment and personnel as described below:

The PERMITTEE, in consideration for use of the above listed facilities, shall remit a one time payment of \$_____, made payable to **Lake Cuyamaca Recreation and Park District**. Fee is due and payable in full prior to use of our facilities. NO EXCEPTIONS.

THE FOLLOWING CONDITIONS ARE IMPOSED WITH THE GRANTING OF THIS PERMIT:

1. The PERMITTEE agrees to indemnify, defend, and hold harmless GRANTOR, its officers, agents, employees and volunteers from and against any and all claims, demands, liabilities or loss of any kind or nature which GRANTOR, its officers, agents, employees or volunteers may sustain or incur or which may be imposed on them for injury to or death of persons, or damage to property as a result of or in any manner connected with this permit.
2. The PERMITTEE will provide to GRANTOR, a General Liability Insurance Policy naming Lake Cuyamaca Recreation and Park District as an "Additional Insured" and **NOT** "Named Insured". The minimum limits shall be \$1,000,000, each occurrence with an aggregate limit of \$2,000,000, for this site only. The insurer shall eliminate such deductibles or self-insured retentions as respects the District, its officers, agents, employees and volunteers. At PERMITTEE'S option a bond may be secured guaranteeing payment of deductibles or self-insured retentions. PERMITTEE'S COVERAGE SHALL BE PRIMARY and Grantor's insurance shall be in excess of PERMITTEE'S insurance and shall not contribute with it.

3. The terms and conditions of this permit shall be binding on the PERMITTEE, its officers, agents, employees or persons participating in programs sponsored by PERMITTEE.
4. This permit requires compliance with all the applicable rules and regulations of the Lake Cuyamaca Recreation and Park District.
5. GRANTOR reserves the right to deny the use of the lake, personnel and equipment at anytime, without prior notice and without refund of fees, to anyone who does not obey the applicable rules and regulations of the Lake Cuyamaca Recreation and Park District or orders from the authorized agent of the GRANTOR.
6. This permit is personal to the PERMITTEE; and attempted transfer, assignment, or conveyance without prior written consent of the GRANTOR shall terminate this permit automatically.

This document constitutes the entire agreement between the GRANTOR and the PERMITTEE.
